## FRACTIONAL ENTITLEMENT AND DEALINGS IN SECURITIES

### Fractional entitlement

Lighthouse shareholders are referred to the declaration announcement released on SENS on Tuesday, 30 August 2022 and the circular ("**Circular**") distributed to shareholders in this regard, wherein shareholders were advised that the board of directors ("**Board**") had approved an interim scrip distribution of 1.62500 EUR cents per Lighthouse share in respect of the six months ended 30 June 2022 ("**Scrip Distribution**"), with an alternative cash distribution option of 1.46200 EUR cents per Lighthouse share ("**Cash Distribution**"), which Cash Distribution represents a 10% discount to the Scrip Distribution.

The allocation of new Lighthouse shares will be such that shareholders receiving the Scrip Distribution will not be allocated a fraction of a new Lighthouse share. Any entitlement to receive a fraction of a new Lighthouse share will be rounded down to the nearest whole number and a cash payment will be made for the fraction.

The fraction rate has been calculated as the volume weighted price of a Lighthouse share traded on the JSE on Wednesday, 14 September 2022 (being the day on which Lighthouse shares commenced trading "ex" the entitlement to receive the distribution) of EUR0.37396/ZAR6.50655 discounted by 10%. The fraction rate paid will be EUR0.33656/ZAR5.85590 per Lighthouse share. The fraction rate paid will be subject to dividends tax at a rate of 20%.
